Pursuant to Item 1 of I-05¹ and Item 6 of II-23² of the Bidding Procedures for the *Competitive Selection Process for the Procurement of Power Supply for the Province of Siquijor* (the “Transaction”), the PROSIELCO Bids and Awards Committee (“PROSIELCO-BAC”) hereby issues this Bid Bulletin No. 3.

This is to inform all bidders that two (2) minor issues have been identified in the *Schedules* of the Bidding Procedures which require correction:

1. **Schedule 18.** Certain designated cells in Row 96 of the MS Excel file for Schedule 18 were inadvertently locked, preventing bidders from inputting their desired indexation. To address this, the PROSIELCO-BAC hereby issues a corrected version of Schedule 18, enabling bidders to input the required data.

Again, certain cells in Row 96 of Schedule 18 was simply unlocked to allow bidder input. No underlying data, formula, or syntax in the MS Excel file of Schedule 18 has been changed.

2. **Schedule 12 and Schedule 13.** The labels of Schedules 12 and 13 in the provided templates were inadvertently interchanged. The PROSIELCO-BAC will issue corrected versions of these schedules to properly align with requirements B and C of Envelope 1, Folder 1-3 under the Financial Eligibility Documents (page 29 of the Bidding Procedures). This was solely a labeling error, and no substantive changes have been made to either of the two (2) schedules.

Note: All other allowed revisions or modifications to the *Schedules* of the Bidding Procedures, as previously accepted under earlier Bid Bulletins, shall be accepted.

Corrected versions of Schedules 12, 13, and 18 shall be distributed to all prospective bidders via their registered email addresses. Apart from these corrections, no other changes have been made to any portion of the Final Transaction Documents.

Bidders are also reminded that the submission, opening, and evaluation of bids shall proceed as scheduled on October 07, 2025 at 9:30 AM at El Pergentina Resort Function Hall in Tinago, Siquijor, Siquijor.
