All Bids shall be opened and read in the presence of Bidders or their duly authorized representatives. Bidders shall be required to put up a Bid Security in the amount equivalent to 2% of the ABC. The Bid Security shall be in the form of cash or manager's check and submitted

together with their Bids. The presence of bidders during the pre-bid conference is **NOT MANDATORY**.

Only those bidders who have bought the bidding documents shall be allowed to raise or submit written queries or clarifications and participate the Submission and Opening of Bids.

The Pre-Bid Conference, Submission and Opening of Bids will be held via face-to-face at PROSIELCO Office, Nonoc, Larena, Siquijor (Solidarity Hall).
