For the Distribution Line Extension for three (3) Sitios and the electrification of thirty-seven (37) households in the province of Siquijor under the Locally Funded Project- Total Electrification Project of the Department of Energy (DOE) for Fiscal Year through 2025 GAA

Through DOE's Locally Funded Project-Total Electrification Project (TEP), the three (3) Sitios namely: 1) Alangilan of Barangay Cangclaran, Lazi; 2) Ambalang of Barangay Maite, San Juan and 3) Purok Cansilo of Barangay Bogo, Maria have qualified for energization to be funded by the General Appropriation's Act (GAA) of DOE for Fiscal Year 2025 with a total project cost of **Four Million Three Hundred Ninety-Three Thousand Five Hundred Eighty-Two & 03/100 Pesos (P4,393,582.03)**.

The PROSIELCO, through its Bids and Awards Committee (BAC) now invites bids for the **SUPPLY AND DELIVERY OF MATERIALS, CONSTRUCTION OF LINE and HOUSEWIRING INSTALLATION FOR THE IMPLEMENTATION OF THE TOTAL ELECTRIFICATION PROJECT (TEP) OF DOE FOR THE YEAR 2025** to be undertaken by PROSIELCO. Delivery of goods and services is required within a period of one hundred eighty (180) days upon receipt of the project funds and after the awarding of contract/ issuance of the Notice to Proceed to the winning bidder. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2025 Implementing Rules and Regulations (IRR) of Republic Act (RA) 12009 otherwise known as the "New Government Procurement Law".

a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to R.A. No. 5183.

A complete set of Bidding Documents may be purchased by interested Bidders on **February 12-17, 2026** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of *Php5,000.00*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees after payment has been made.

The PROSIELCO will hold a **Pre-Bid Conference** on **February 20, 2026** through video conferencing via Zoom at **9:00 'clock in the morning** which shall be open only to all interested parties who have purchased the Bidding Documents

Bids must be delivered to the address below on or before **March 12, 2026 (until 10:00 o'clock in the morning)** which must be duly received by the BAC Secretariat through manual submission. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.

Bid opening shall be on **March 12, 2026 at 10:00 o'clock in the morning** at *Aquamare Beach Camp, Sandugan, Larena, Siquijor*. Bids will be opened in the presence of the Bidders or their representatives. Late bids shall not be accepted.

The PROSIELCO reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
